**NOTICE IS ALSO HEREBY GIVEN** pursuant to Section 91 of the Companies Act, 2013, read with Rule 10 of the Companies (Management and Administration) Rules, 2014 and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, that the Register of Members and Share Transfer Books of the Company shall remain closed from Monday, the 23<sup>rd</sup> September, 2019 to Monday, the 30<sup>th</sup> September, 2019 (both days inclusive).

**NOTICE IS ALSO HEREBY GIVEN** in pursuance of provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing facility to its Members holding shares in physical or dematerialized form as on the cut-off date, being 23<sup>rd</sup> September, 2019 to exercise their right to vote by electronic means on any or all of the businesses specified in the Notice convening the 27<sup>th</sup> AGM of the Company as mentioned above from a place other than the venue of the AGM ('remote e-voting') provided by Central Depository Services (India) Limited (CDSL) and the business may be transacted through remote e-voting. Notice of the AGM shall also be available on the website of CDSL (www.evotingindia.com).

The remote e-voting facility commencement of remote e-voting: 9.00 a.m. (IST) on, 27<sup>th</sup> September, 2019. End of remote e-voting : 5.00 p.m. (IST) on 29<sup>th</sup> September, 2019.

During this period, members may cast their vote electronically. The remote e-voting module shall be disabled for voting thereafter by CDSL and voting through electronic means shall not be allowed beyond the said date and time. The facility for voting through ballot paper shall be made available at the AGM and the members attending the meeting who have not casted their vote by remote e-voting shall be able to exercise their right at the meeting through ballot paper. The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

The voting rights of Members shall be in proportion to the Equity Shares held by them in the paid up equity share capital of the Company as on 23<sup>rd</sup> September, 2019 ('cut-off date'). Any person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only, shall be eligible to cast vote on all the resolutions set forth in the Notice of AGM either through remote e-voting or ballot paper at the AGM.
