To the Members of **RCI WINDFARM 30 MW PRIVATE LIMITED**

### Report on the Audit of the Standalone Financial Statements

#### Opinion

I have audited the standalone financial statements of RCI Windfarm 30 MW Private Limited (hereinafter referred to as "the Company"), which comprise the Standalone Balance Sheet as at 31<sup>st</sup> March 2022, and the Standalone Statement of Profit and Loss (including other comprehensive income), Standalone Statement of Changes in Equity and Standalone Statement of Cash Flows for the year then ended, and notes to the standalone financial statements, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the standalone financial statements").

#### Key Audit Matters

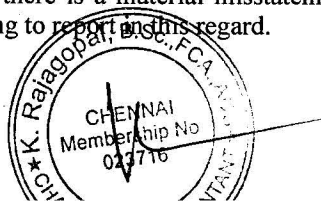

The Company's board of directors is responsible for the preparation of the other information. Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

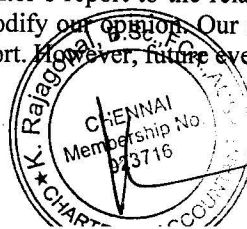
Those Board of Directors are also responsible for overseeing the Company's financial reporting process.

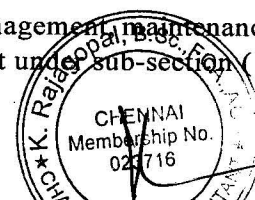

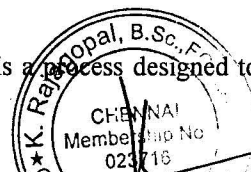


